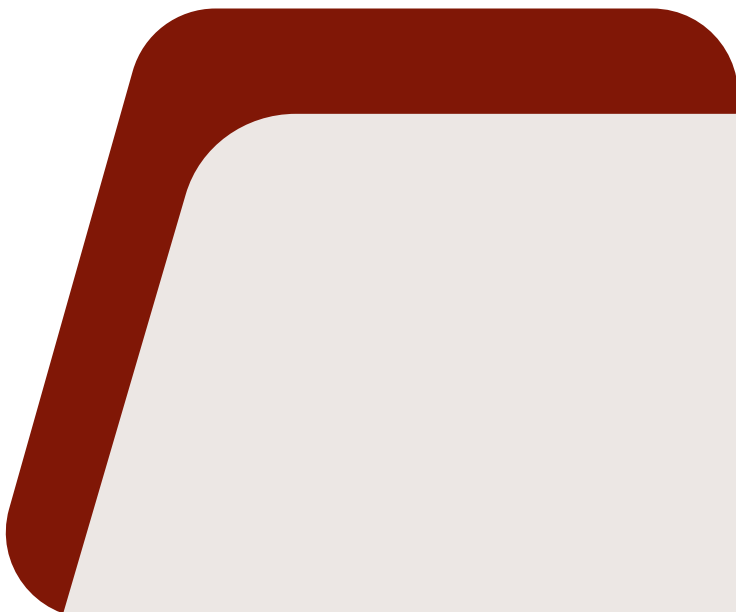
# ABOUT COMPANY
